

# **History Commission Minutes**

#### I. Call to Order

Chairman Michael Williams called the meeting to order at 6:05 pm.

# III. Approval of Minutes from September 9, 2025

Motion to approve by Inez Brown Crouch, seconded by Jay Reese; approved.

**IV. Public Comments** – Julia Drayton-Crumblin introduced herself to the group and indicated she is running for Town Council, noting that she grew up on the island and is starting a daycare.

### V. Reports:

a. Town Market Outreach:

Jay Reese and Bill Lyon reported that the October market might have been the busiest market yet. While the topic was Mill Point Park there were many questions about a wide variety of topics regarding James Island.

The Commission discussed the list of themes for future markets, with a list from the market subcommittee. Afte much discussion, the upcoming market themes decided upon were:

November 7, 2025: Native Americans December 5, 2025: History of the Town

January 2, 2026: The Revolutionary War February 6, 2026: Black History / Segregation

March 6, 2026: Historical Marker Program

April 3, 2026: Lawton Bluff

May 1, 2026: Gullah Geechee History
June 5, 2026: Simeon Pinckney Park

September 4, 2026: Sea Island Lodge and Mosquito Fleet

#### b. Historic Markers:

## Procedure

The amended procedure document was presented by Mayor Lyon. With one further minor amendment, Michael Williams motioned to approve the procedure, Jim Morrisette Seconded; procedure approved.

## In-Process

Mike Hemmer noted the status of the active applications:

- Three Trees has been submitted, waiting for wording
- Payne RMUE has been submitted
- St. James Episcopal has been submitted
- First Baptists has been recently submitted

There continued to be discussion about the need to contact representatives of the property nearby these markers to know where the marker will be installed, well before the marker is received by the Town, noting that Three Trees is becoming pressing. Michael Williams noted there would be some clean-up of sites, along with he Simeon Pinckney replica that he would conduct soon.

Michael Williams had no update, but he did note that the Grant's Store video has seen an uptick in activity.

## Pinckney Memorial Marker

Michael Williams and Mayor Lyon noted that the monument company should install in early November and the Town is planning a public ceremony on November 15<sup>th</sup>. A caterer has been obtained and the public will be invited.
