II. Committee Reports

- A. Helping Hands
 - 1. New work dates set for 2024: April 20, May 25, June 29, July 20, August 24, September 28, October 19. Meet at Pinckney Park @ 9:00 am.
 - Equipment for the new year was looked over on March 16, \$200 was spent on tune-up equipment. Possible additional money needed for new lawnmower blades (approved). Stan has purchased numbers for mailboxes to aid in identification.

Hello DeAnn and Gary,

Looks like we all share a common interest in bringing our retention pond/park area up to it's full potential. I'm taking the lead for the group (took a hit in order to avoid officially becoming a HOA Board Member again... haha). We are currently using a landscaping service to just do the very basics. The landscaper is much more capable than we're currently paying for. We have his creativity and labor to leverage, along with the hands of the 17 homeowners within our HOA. If we plan this right, we can turn a great plan into one big day of transitioning to achieve a neighborhood corner park that we can all be proud of.

There are a few major factors we should consider sooner than later, so I'll throw these out there now for pondering.

- 1. The apartment complex on Julian Clark/Dills Bluff (and perhaps some other folks not related to this property) regularly gut kitchens, bathrooms, etc. and use this stretch between the stop sign and Mcelveen Street as a dumping ground. How can we reduce this activity in a natural way vs. putting huge, unsightly signs up?
- 2. How can we make the park LOOK inviting without being TOO INVITING? We, of course, pay for insurance. We want this area to be appealing to everyone, but we don't want it to become a space for loitering or entertainment for non-residents. From a town council perspective, I'm sure you have some creative ideas and lessons learned from other areas on the island.
- 3. I would like to create 2-3 development options, with cost and labor requirements included, in order to get a vote from our residents before the end of the year. This would also allow us some time in selecting additional outside resources needed and confirmation of our budgeting.

I'm really happy to be working with JI Pride! What a cool way to serve our community. Thank you in advance and all the best to you and yours this Thanksgiving.
