# **Rethink Folly Road**

The Town of James Island is working with the City of Charleston, Charleston County, and the City of Folly Beach to improve Folly Road. Mayor Woolsey is Chairman of the steering committee and Charleston City Councilwoman Kathleen Wilson is Vice Chairman. The goal is to make Folly Road safer for pedestrians and bicyclists—to make it a place to stop and shop rather than just pass through.

The Camp and Folly intersection improvement long preceded Rethink Folly Road, but it has always included sidewalks and bike lanes. It also includes a widening so that traffic moves more rapidly through the Camp and Folly intersections. Drainage is part of that project as well, increasing the capacity of pipes under Folly Road to reduce flooding. The Town saw an opportunity with Walgreens redeveloping to incorporate a bus pullout into the intersection improvement plans, and we will be installing a bus shelter at this location. The projected completion date is scheduled for early 2018.

The Town has developed plans to complete the sidewalks on the west side of Folly from Camp Road to Ellis Creek. The Town has applied to the Berkeley-Charleston-Dorchester Council of Governments for a grant using complete streets funding along with a match of hospitality funds. The Town is looking to provide off-street parking to help with the existing problem along Santee Street.

The Town participated in a meeting with Charleston County and the City of Charleston regarding priorities for the newly passed  $\frac{1}{2}$  cent sales tax on James Island. Completing sidewalks from Camp Road to George Griffith Road on the west side of Folly should start soon.

Mayor Woolsey explained, "the recent deaths of two pedestrians on Folly Road makes pedestrian improvements a priority." Other intersection improvements are in the works as a part of the recently passed ½ cent sales tax referendum. The Charleston



County Transportation Department in conjunction with the Town of James Island, City of Charleston and SCDOT are currently evaluating those projects to include the intersections of Central Park at Riverland Drive, Secessionville Rd at Ft Johnson Rd, and Camp Rd at Ft Johnson Rd.

## **Improving Connectivity**

Creating safe, pedestrian and bicycle friendly paths are an important way the Town is improving the quality of life for its residents. This past year, the Town with funding assistance from County Sales Tax, completed the Fort Johnson Sidewalk connector project along Camp and Dills Bluff Rd. Currently, Phase I of the Dills Bluff sidewalk project that will connect existing sidewalk to Seaside Lane is under construction and expected to be complete by December. Phase II, which will include a boardwalk, is in the permitting stage, and Phase III is under design. The goal is to ultimately connect Dills Bluff Rd to the new sidewalk on Harbor View Rd. The Town is also in the permitting stage for the Seaside Lane sidewalk project, and the Lighthouse Blvd Phase I sidewalk project. Completing sidewalk infill projects along sections of Folly Rd are also under design.

# **New Town Hall Groundbreaking**

The Town of James Island officially broke ground on its new space in July. Investing in its own facilities not only made financial sense, but also will serve to provide a more functional space for its staff and residents. With southern vernacular weaved throughout from the porch to the metal roof, the local firm of Liollio Architects designed a Town Hall everyone can be proud of. The Council Chambers is in a separate attached building so it can function as meeting space for the community and various committees, while the office space and two conference rooms are housed in the main building. The Town settled on a site that is close to its current office space, but also one that boasts natural beauty. The site along Dills Bluff Rd, near the intersection of Camp Rd, features many beautiful live oak trees, and a very large, unique magnolia tree. Blanchard Construction is bringing this project to completion, with a move-in date set for the spring of 2018.

### Flooding, Drainage, and What you Need to Know

Even if your property is not within a flood zone, all areas within the Lowcountry are still at risk for flooding. If you are planning on remodeling or doing any work to your home, check with Building Services to make sure your new construction is up to code. Purchasing flood insurance, even if flood insurance is not required for your property, is a great idea since homeowners insurance does not cover flooding. Flood insurance is available through the National Flood Insurance Program (NFIP). Visit FloodSmart.gov or contact your insurance agent for more details. Keeping the island's ditches free and clear is crucially important in helping stormwater runoff get to where it needs to go, and reducing the risk of flooding. In order to ensure your ditches are routinely maintained, the Town is working to secure drainage easements where they do not exist and working with property owners to accomplish this task. The main thing a homeowner can do is make sure not to pile leaves and other debris in the roadside ditches, and not build structures or install large plantings within existing drainage easements. Contact the Town to request a ditch cleaning or report dumping violations before a storm occurs.

## Pinckney Park is Open, and Phase II Underway

This past May, the Town proudly opened its newest park for residents and visitors to enjoy, located at 461 Fort Johnson Rd, just before the entrance to the DNR facilities. The Town purchased the land in 2015 with Charleston County 1/2-cent sales tax Greenbelt Funds, money set aside to preserve land in the low country. Hussey Gay Bell Engineers began working on the Master Plan, and with a great deal of input from neighboring residents it was approved in 2016 and construction of Phase I was underway. The park boasts a natural setting with walking trails and a playground. The playground features a Hoopla swing that can be enjoyed by children with or without disabilities. Phase II will include a screened-in picnic shelter and restrooms.



Later phases are set to provide an outdoor classroom and boardwalk overlooking the marsh and a tributary of Parrott Creek. # Hurricane Matthew Wrap-up and a Look Ahead at Hurricane Season

In October of 2016, Hurricane Matthew ravaged the East Coast, hovering over South Carolina and dumping large amounts of rain on already saturated soils. There was a great deal of damage to parts of the low country and the midlands, and fortunately, James Island fared better than other parts of the state. As part of the Town's Emergency Operations Plan, staff and officials evacuated to Greenwood, SC where they were able to operate from the Greenwood County Emergency Management offices and fielded resident phone calls, coordinated efforts and participated in daily updates with both Charleston County and the State EMD. Power outages and fallen tree limbs were the major concerns upon return. Months before the storm, the Town had renewed its agreement with Charleston County who manages the debris removal contracts. For this upcoming storm season, the Town will be looking into the effectiveness of sand bag deployment and assisting in locating additional debris transfer sites on James Island. The Town urges all residents to sign up for the Charleston County Citizen Alert Notification System, and download a copy of the 2017 Charleston County Hurricane Guide. 

## **Did Someone Say Moratorium?**

The recent closing of a local theater and plans to build an apartment complex in its place spurred much debate and discussion about a development moratorium on James Island. At the regular biannual meeting of the Intergovernmental Council chaired by James Island Councilman and Mayor Pro Tem Leonard Blank, local elected officials from all jurisdictions centered their discussion on a moratorium and moving forward with a cohesive plan for James Island. While the Town of James Island already limits density in commercial areas to four units to per acre, it was important to show solidarity and support the City's efforts in taking a hard look at their land use plan for areas within its jurisdiction on James Island. Both the City of Charleston and Town of James Island passed apartment moratoriums for James Island and staff from both municipalities and County representatives as well have been working on proposed changes to present their respective Councils later this year. The Town's moratorium does not restrict redevelopment consistent with the Folly Road Overlay Corridor, and the Town will continue to promote positive redevelopment that serves to improve pedestrian safety and public transit for the island, while limiting high-density housing.
