Mayor Woolsey's Corner

The Town has made great progress in our third year. We completed our first sidewalk project last summer and construction began on our first paving project on Ben Road. We anticipate construction starting on two more sidewalk projects and another road paving project this summer.

We continue to transition services from County to Town Hall. Routine residential zoning permits are now handled by Planning Director Kristen Crane. We are expanding the building services available at Town Hall and plan to begin issuing licenses for brick and mortar and home businesses here by the end of the year.

The Town continues to improve Dock Street Park and also has a contract to purchase 7.5 acres for our new Pinckney Park. We expect to close by the fall.

Rep. McCoy has filed new annexation legislation. He believes it has a good chance to pass the House this year and should go to the SC Senate early next

year. We remain committed to reuniting the Town.

I have proposed a tax relief plan that will allow homeowners to see a 14% reduction in their property tax bill.

We have introduced a home repair program and are looking for a site for a new Town Hall.

Repair Care Program - Fixing homes on James Island

Town of James Island residents in need of home Sea Island Habitat for repairs are invited to apply Humanity will review for assistance from the new Repair Care Program. This program is a partnership between the Town and Sea Island Habitat for Humanity (SIHH).

Town Council recently voted to fund the program with \$30,000, which will fund repair projects with a cost in the range of \$3,000 to \$5,000 per home. The goal is to address critical needs such as roofs, ramps and

window replacements. requested projects and perform the repair work.

Repair Care beneficiaries and their families are expected to help to the extent possible when construction crews are on site and also make a modest monthly payment to share in the costs.

Homeowners whose incomes fall between 15% to 80% of the area median income may apply. Applications are available

on line at: http://www.iamesislandsc. us and at the Town of James Island, Town Hall, 1238-B Camp Road. There is no deadline to apply. Applications will be reviewed to ensure that residency and other requirements are met. The projects will be completed on a rolling basis.

Town citizens have been asking for help of this kind for a while. The Town has responded with this creative solution.

Coming Soon, Pinkney Park!

As you may recall, the Town was seeking property to purchase for a Town Park with Greenbelt funds. In 2013, the Town sought public input which revealed that our citizens preferred a large park located in the Fort Johnson or Harbor View area. We also asked in our last newsletter to let us know your thoughts on our new park. Fortunately, the Town has been able to negotiate a pending sale of approximately 7 1/2

acres off of Fort Johnson Rd. The Town is very excited, as this property offers stunning marsh views, majestic trees, and easy access for residents. The estimated closing time for this property transaction is late fall of 2015. Shortly thereafter, the Town will seek an engineering firm to help with a conceptual plan for the park. This process will include a great deal of public input

from start to finish. We want to know what you want in your next Town Park. Walking trails? A boardwalk? All ideas will be welcome and we look forward to giving the public access to this beautiful, natural setting.

The name "Pinkney Park" comes from the Pinkney family who have owned this land for generations.

James Island Youth Soccer Club

Building Better Infrastructure

The Town has made great progress in its mission to improve sidewalks and roads in the Town. Last year, the Town completed a sidewalk on Foxcroft Road and also an erosion control project along Sweetgrass Creek.

Construction should begin soon on sidewalks along Jerome and Stiles Drive from Fort Johnson to Mikell. We also anticipate construction beginning for for Phase I of the Camp Road sidewalk from Fort Johnson to Dills Bluff, which will then continue down Dills Bluff back to Fort Johnson.

Engineering for Phase II of our Camp Road sidewalk project (the stretch between Dills Bluff and Secessionville) is now

ReThink Folly Road

Rethink Folly Road: a Complete Streets study is being undertaken by the Berkeley-Charleston-Dorchester Council of Governments (BCDCOG) in association with the City of Charleston, the South Carolina Department of Transportation (SCDOT), the Charleston Area Regional Transit Authority (CARTA), the Town of James Island, the City of Folly Beach, and Charleston County. The purpose of this study is to explore the potential to remake Folly Road a more sustainable, multimodal corridor, which could

complete and we are seeking a CTC match for construction.

We will be funding design work for sidewalks along Quail Drive and Lighthouse Point Drive this year. We also will be funding a conceptual plan for a sidewalk along Dills Bluff Road connecting to the sidewalk slated for Harborview Rd.

The Town is leading a joint effort with City of Charleston, Charleston County, Bishop Gadsden, and CCPRC to develop a conceptual plan for a sidewalk along Camp Road between Folly Road and Riverland Drive.

The Town has provided matches for two pervious paving projects managed by Charleston County. The Ben Road project is currently under construction with the paving of Jeffrey and Lemontree to follow. Completion of both is expected before the end of the summer.

Charleston County's Harbor View Road project is well underway with completion scheduled for early 2016. That project will include bike paths and sidewalks from Fort Johnson to North Shore Drive.

Intersection Improvements at Camp and Folly Rd. have been delayed and the County is working towards rebidding that project. For more info on these two projects, visit http://roads.charlestoncou nty.org/projects. Groundbreaking for Ben Road

From May 7-13, a design charrette was held, and a team of planning, urban design, transportation, economics, and green infrastructure experts worked with the community to develop a plan for the future of the Folly Road corridor, from Center Street on Folly Beach to the Wappoo Cut Bridge.

The Steering Committee has been charged with reviewing the input received from the public charrette and helping to integrate that into a comprehensive plan. Planning Director Kristen Crane, Mayor Pro-Tem Leonard Blank and Planning Commission Chairman David Bevon represent the Town on the Steering Committee.

We remain committed to providing an opportunity for all of our former citizens to again be part of the Town of James Island.

Rep. Peter McCoy filed annexation legislation to modify the legal definition of contiguity. House Bill 4203 applies when a municipality is entirely included in a special purpose district with an elected governing body. The bill makes property that would be contiguous but for a break in the contiguity of the special purpose district legally contiguous with the municipality.

Reuniting Our Town – Annexation Update

The Town is entirely included in the JIPSD which has elected Commissioners. When signed into law, this bill will allow us to reach parts of James Island separated from the Town by areas annexed to the City of Charleston. We will be able to annex individual properties at the request of the owners or organize petition drives and hold annexation elections as we did last year.

Rep McCoy believes the bill has a good chance to pass the SC House this year so that the SC Senate can consider it early next year.

Tax Relief Plan

I remain deeply committed to providing property tax relief to the people of the Town.

This is more important than ever with the JIPSD planning to increase their millage from 51.1 to 53.1 mills next year, an approximate 4% increase. They intend to increase their taxes an additional 4% in the next 5 years.

I have a plan to instead allow the JIPSD to cut their millage to 35.4 mills, an approximate 31% tax cut.

How does the plan work?

The plan is to ask the JIPSD to transfer the service rights to solid waste collection to the Town and continue to

provide garbage and trash pickup to Town residents by contract. The Town would agree to pay the JIPSD nearly \$1 million per year to provide solid waste collection.

The Town would need to introduce a property tax of 17.7 mills, but since the Town must provide a Local Option Sales Tax (LOST) property tax credit against its own millage, no one would pay any property tax to the Town.

What would this mean for the average taxpayer in the Town?

The JIPSD would continue to provide excellent garbage and trash pickup as determined by the JIPSD Commissioners.

On your County tax bill, the line for the operating millage for the JIPSD

would be reduced from 51.1 to 35.4. The amount billed by the JIPSD for a \$200,000 home would go down from \$409 to \$283. There would be a new Town LOST tax credit of \$142 shown on the tax bill. There would be a new line for the Town's 17.7 operating millage, but the amount billed on that line would be \$0.

Compared to last year, the total property taxes on the County tax bill would be 14% lower for a home, 7% lower for a car, and 6% lower for a boat.

The plan would not impact the JIPSD fire or sewer services, taxes of fees.



If you can reach the tree with a garden hose, run it for about a minute twice a week. or you can tote 2 gallons jugs of water to the tree 3 days a week. Already the leaves on some of the trees have turned brown but the trees are not dead. Trees will drop leaves when they are under stress. They will leaf out again if they get enough water. Thank you for your help in restoring the tree canopy over our new sidewalks!
