The Planning Commission met on Thursday, July 9, 2020 at 6:47 p.m. by virtual platform (Zoom). This meeting was held in a workshop setting to review the Town of James Island's Comprehensive Plan. Staff were present at the Town Hall, 1122 Dills Bluff Road, James Island, SC.

<u>Planning Commissioners present</u>: Lyndy Palmer, Vice Chair, Bill Lyon, Ed Steers, Zennie Quinn, and David Bevon, Chairman presided. <u>Also</u>: Kristen Crane, Planning Director, Flannery Wood, Planner I, Cynthia Mignano, Town Council, Ashley Kellahan, Town Administrator, Mark Johnson, Public Works Director, and Frances Simmons, Town Clerk and Secretary to the Planning Commission.

<u>Call to Order</u>: Chairman Bevon called the meeting to order at 6:47 p.m. A quorum was present to conduct business.

Compliance with the Freedom of Information Act: In compliance with the Freedom of Information Act and the requirements of the Town of James Island, members of the public were provided a link to the proceedings of the meeting. The public was also encouraged to submit comments or questions regarding the 5-year review of the Comprehensive Plan by email to the Planning Director at planning@jamesislandsc.us or to appear in person at the Town Hall to speak during the Public Comment portion of the meeting.

<u>Approval of June 11. 2020 Minutes</u>: Chairman Bevon moved for approval, seconded by Commissioner Steers, and passed unanimously.

Other Discussion:

Research connectivity from Buxton Bridge to HV Circle with City of Charleston/Federal funding

Add Harbor View Road under Strategy and Time Frame. Councilwoman Mignano suggested looking into the feasibility of having a wooden bridge (i.e., Dills Bluff) having the least impact on the marsh while providing safety to people. Bridge is in the City, but Town could collaborate with them. This could be a wooden walkway on pilings that would not impact this beautiful view. Mrs. Crane to add sentence to reflect this in the plan.

Commissioner Quinn asked the timeframe for completion of the Comprehensive Plan. Mrs. Crane said the Comprehensive Plan is still on schedule. She hopes to have a semi-draft in August and the Planning Commission vote in September; then it would go to Town Council in October or November.

Commissioner Quinn asked that Town Councils and Committees be included in the Plan. Councilwoman Mignano suggested for ease in location, to place them all in one section with a brief description of each. Note: that meeting dates/times are subject to change. Also add information on James Island Outreach, Repair Care, and Blessing Boxes.

Chair's Comments: Chairman Bevon thanked the staff for their hard work on the Comprehensive Plan.
