I would like to voice my opinion on the project to improve the intersection at Camp and Fort Johnson Roads. As a native James Islander, I have seen this intersection be the site of many car accidents. Now as a parent, traveling to and from the Bayview Soccer Complex, I frequently take the route that passes or includes this intersection. Because of the difficulty in seeing oncoming traffic and the line of traffic that backs up on Camp Road to turn left onto Fort Johnson, I regularly take a longer route to avoid this intersection. I have also recently noticed more pedestrians and bicyclists around this intersection, perhaps traveling to/from the restaurants at Camp & Dill. Having a safer roundabout traffic pattern at this intersection would not only be safer for vehicular traffic but also for pedestrians and bicyclists. Hello! My name is Richard Koger and I was a firefighter with the City of Charleston from 1982 to 2006. I spent a combined 10 years in the City's Station 7 at Stonepost and Ft. Johnson Road. I commented on Kathy Woosley's comment on Facebook and she suggested I forward my information to you.

I was stationed there from 1987 to 92 and again from 1999 to 2005. I can not tell you how many times we would be sitting there when we would hear that awful sound of metal crashing with a loud thud. There were times it would shake the building. The bad part is not only was the sound awful but in running out we found people bloody and sometimes badly injured.

Even though this intersection was in the JIPSD district and so we always called them to respond also. I mentioned that if someone wanted to find documentation of all the times we responded it can be found in the handwritten journals that we had to log every incident into. As I understand, these journals must be kept. Unfortunately computers were not used till the early 2000's. I am also sure that JIPSD has their records also available.

There is another dangerous situation on that corner that will not be addressed by a roundabout. It is the very deep ditch that runs along the south side of Ft. Johnson Road. Again I can not put a number of times we had cars end up in those ditches also causing personal injury to the occupants of those vehicles. There in my opinion needs to be a guard rail placed along this ditch to keep that from happening.

We never saw those stone posts move but they were damaged many times as well as our front yard torn up. I can tell ya that a lot of time alcohol was involved . In my opinion the slight curve in Camp Road approaching Ft. Johnson RD. as well as the trees causing a dark approach to the intersection caused a visual distortion of depth as they fly down Camp road. We used to discuss why nothing was ever done to correct these issues . I can't believe it has taken this long to reach this point of doing something to protect our citizens.

I am not sure any of this helps you in any way but I am glad it has come time.

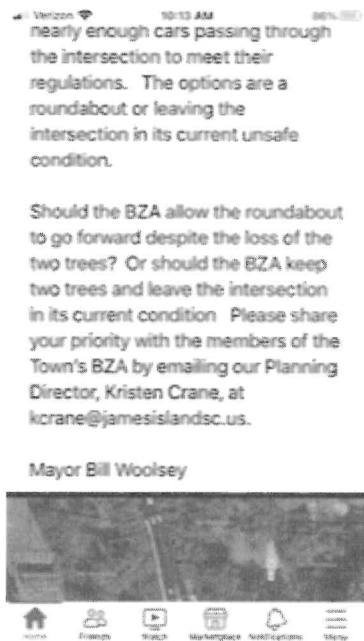

Hi, my name is Charlie Johnson. I live out here on Folly. I used to live in Parrot Creek with my late folks from '87 to '16 off and on. They are buried at St. James on Camp Road. I would drive on the intersection at Camp and Ft. Johnson all the time. I recommend the tree removal option of the roundabout and removal of the two trees and leave the rest of the trees. The roundabouts at Harbor View and Ft. Johnson and at Camp and at the end of Camp at Riverland Dr. turned out to work well. One more Camp Rd. roundabout would go well with the other one, providing continuity of landscape design. What I recommend for the trees that would be removed is to save the wood and hire some artist or artists that can do woodcarving, and create art on the tree trunks, maybe cut off all the bark and carve into them. I assume they are live oaks. That wood never rots if positioned right, perhaps on concrete or metal pedestals somehow as sculptures. These could go back into the roundabout centers as art that was there 150 years ago. Some could go in front of the James Island government center there on Sessionville Road, in and outside the building. There's a guy in Mt. Pleasant on Coleman Blvd. near Shem Creek who is a really good chain saw artist, Chris Cox is his name, maybe contact him. Indians in the Pacific Northwest keep all the large cut down trees and fashion tall sculptures from them. They would never just toss a 150 year old tree, particularly a live oak, I'm sure to appease the spirits they believe in. Angel Oak is a live oak, if the wood gets tossed that might bring bad luck because of Angel Oak and angels such as the angels in lights over at the park on Riverland and the drive through at Christmas. I'm an artist, and I look at live oak as just a fantastic art material. I have saved alot of cut down live oak trunks I would see on the side of the road here on Folly and on James Island getting tossed after being cut down, and I have in my yard for rustic landscape art. I get good exercise picking them up and putting them in the back of my pickup truck. I'm fairly strong and get the workout plus the live oak trunks at the same time. The live oaks at Folly and the 526 intersection were saved. It would be best to build the roundabout and save almost all the trees, and harvest the downed ones and hire an artist to make art and leave it on James Island, no transportation to MUSC and the River Tower lobby or the horseshoe or anything off the island. I am 71 years old today, November 15th, about half the age of the trees.
